## **PERSONAL DATA PROCESSING POLICY STATEMENT**

By means of this statement, we hereby notify you of the following in the context of the implementation of the new General Data Protection Regulation (EU) 2016/679, which entered into force on 25/05/2018, hereinafter referred to as "GDPR".

For the achievement of the above insurance brokerage purposes, our company shares your personal data exclusively with insurance companies and other insurance brokerage companies (i.e. insurance brokers), if necessary, in order to find suitable, according to your needs, insurance products.

Our company will retain and process your personal data for as long as you remain our active customers. In the event that our relationship is terminated (you cease to maintain active insurance policies through our company), then your personal data will be retained for as long as required under applicable law or until the limitation period for any relevant claims has expired.

The rights you can exercise regarding your personal data are: The right of access, correction, portability and, if the legal requirements are met, deletion, restriction and opposition.
